

# Weekly Analysis

## March 16, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 6,445 last week, a decrease of 1.9 percent from the prior week's figure of 6,568 and a 11.5 percent increase from the March 2018 weekly average of 5,782. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 22. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 67,345 last week, a decrease of 1.3 percent from the prior week's figure of 68,223 and a 3.7 percent increase from the March 2018 weekly average of 64,959. Continued claims under Title 5 totaled 277. EUC continued claims totaled zero while EB continued claims totaled zero.
