

Weekly Analysis

April 27, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 5,659 last week, a decrease of 6.9 percent from the prior week's figure of 6,076 and a 4.0 percent decrease from the April 2018 weekly average of 5,893. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 21. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 48,346 last week, a decrease of 5.4 percent from the prior week's figure of 51,080 and a 27.1 percent decrease from the April 2018 weekly average of 66,344. Continued claims under Title 5 totaled 189. EUC continued claims totaled zero while EB continued claims totaled zero.
