

Weekly Analysis

May 25, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 6,668 last week, a decrease of 32.9 percent from the prior week's figure of 9,941 and a 13.2 percent increase from the May 2018 weekly average of 5,892. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 17. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 46,285 last week, an increase of 7.9 percent from the prior week's figure of 42,904 and a 12.0 percent increase from the May 2018 weekly average of 41,311. Continued claims under Title 5 totaled 194. EUC continued claims totaled zero while EB continued claims totaled zero.
