

Weekly Analysis

June 15, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 5,698 last week, a decrease of 19.3 percent from the prior week's figure of 7,063 and a 10.6 percent decrease from the June 2018 weekly average of 6,373. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 23. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 45,070 last week, a decrease of 3.6 percent from the prior week's figure of 46,743 and a 0.4 percent decrease from the June 2018 weekly average of 45,252. Continued claims under Title 5 totaled 177. EUC continued claims totaled zero while EB continued claims totaled zero.
