

# Weekly Analysis

June 29, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 5,970 last week, a decrease of 0.2 percent from the prior week's figure of 5,980 and a 6.3 percent decrease from the June 2018 weekly average of 6,373. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 45,423 last week, an increase of 1.8 percent from the prior week's figure of 44,621 and a 0.4 percent increase from the June 2018 weekly average of 45,252. Continued claims under Title 5 totaled 177. EUC continued claims totaled zero while EB continued claims totaled zero.
