

Weekly Analysis

August 17, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 4,657 last week, a decrease of 3.1 percent from the prior week's figure of 4,808 and a 1.3 percent increase from the August 2018 weekly average of 4,599. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 33. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,244 last week, a decrease of 3.0 percent from the prior week's figure of 43,542 and a 8.7 percent increase from the August 2018 weekly average of 38,876. Continued claims under Title 5 totaled 224. EUC continued claims totaled zero while EB continued claims totaled zero.
