

Weekly Analysis

December 21, 2019

Ohio Law initial claims, representing newly unemployed persons, totaled 10,619 last week, an increase of 6.3 percent from the prior week's figure of 9,989 and a 6.5 percent decrease from the December 2018 weekly average of 11,352. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 27. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 57,384 last week, an increase of 4.7 percent from the prior week's figure of 54,782 and a 13.9 percent decrease from the December 2018 weekly average of 66,616. Continued claims under Title 5 totaled 253. EUC continued claims totaled zero while EB continued claims totaled zero.
