

# Weekly Analysis

January 18, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 7,817 last week, a decrease of 21.3 percent from the prior week's figure of 9,929 and a 20.2 percent decrease from the January 2019 weekly average of 9,796. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 72,804 last week, a decrease of 6.8 percent from the prior week's figure of 78,141 and a 10.4 percent increase from the January 2019 weekly average of 65,943. Continued claims under Title 5 totaled 261. EUC continued claims totaled zero while EB continued claims totaled zero.
