

Weekly Analysis

February 22, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 6,195 last week, a decrease of 4.8 percent from the prior week's figure of 6,509 and a 1.2 percent increase from the February 2019 weekly average of 6,120. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 13. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 70,793 last week, a decrease of 0.5 percent from the prior week's figure of 71,160 and a 1.6 percent decrease from the February 2019 weekly average of 71,972. Continued claims under Title 5 totaled 229. EUC continued claims totaled zero while EB continued claims totaled zero.
