

# Weekly Analysis

April 11, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 158,678 last week, a decrease of 29.8 percent from the prior week's figure of 226,007 and a 2703.7 percent increase from the April 2019 weekly average of 5,660. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 104. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 622,520 last week, an increase of 38.3 percent from the prior week's figure of 449,999 and a 1171.1 percent increase from the April 2019 weekly average of 48,974. Continued claims under Title 5 totaled 567. EUC continued claims totaled zero while EB continued claims totaled zero.
