

# Weekly Analysis

## April 18, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 109,369 last week, a decrease of 31.1 percent from the prior week's figure of 158,678 and a 1832.5 percent increase from the April 2019 weekly average of 5,660. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 104. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 717,306 last week, an increase of 15.2 percent from the prior week's figure of 622,520 and a 1364.7 percent increase from the April 2019 weekly average of 48,974. Continued claims under Title 5 totaled 594. EUC continued claims totaled zero while EB continued claims totaled zero.
