

# Weekly Analysis

April 25, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 92,920 last week, a decrease of 15.0 percent from the prior week's figure of 109,369 and a 1541.8 percent increase from the April 2019 weekly average of 5,660. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 87. Emergency Unemployment Compensation (EUC08) initial claims totaled zero. Federal-State Extended Benefits (EB) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 776,302 last week, an increase of 8.2 percent from the prior week's figure of 717,306 and a 1485.1 percent increase from the April 2019 weekly average of 48,974. Continued claims under Title 5 totaled 615. EUC continued claims totaled zero while EB continued claims totaled zero.
