

Weekly Analysis

May 30, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 34,566 last week, a decrease of 17.8 percent from the prior week's figure of 42,072 and a 398.4 percent increase from the May 2019 weekly average of 6,935. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 38. Pandemic Unemployment Compensation (PUA) initial claims totaled 30,381.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 550,989 last week, a decrease of 11.5 percent from the prior week's figure of 622,662 and a 1292.8 percent increase from the May 2019 weekly average of 39,560. Continued claims under Title 5 totaled 540. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 12,371 while PUA continued claims totaled 439,430.
