

# Weekly Analysis

August 1, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 25,944 last week, a decrease of 7.1 percent from the prior week's figure of 27,926 and a 473.6 percent increase from the August 2019 weekly average of 4,523. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 45. Pandemic Unemployment Compensation (PUA) initial claims totaled 42,249.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 383,233 last week, a decrease of 4.8 percent from the prior week's figure of 402,742 and a 941.8 percent increase from the August 2019 weekly average of 36,787. Continued claims under Title 5 totaled 477. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 18,753 while PUA continued claims totaled 319,350. Extended Benefits (EB) continued claims totaled 2,433.
