

Weekly Analysis

September 5, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 17,976 last week, a decrease of 3.9 percent from the prior week's figure of 18,711 and a 227.3 percent increase from the September 2019 weekly average of 5,492. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 37. Pandemic Unemployment Compensation (PUA) initial claims totaled 14,050.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 302,440 last week, a decrease of 4.1 percent from the prior week's figure of 315,451 and a 605.6 percent increase from the September 2019 weekly average of 42,862. Continued claims under Title 5 totaled 456. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 18,374 while PUA continued claims totaled 377,085. Extended Benefits (EB) continued claims totaled 7,701.
