

Weekly Analysis

October 3, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 18,573 last week, an increase of 3.7 percent from the prior week's figure of 17,911 and a 192.4 percent increase from the October 2019 weekly average of 6,351. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 46. Pandemic Unemployment Compensation (PUA) initial claims totaled 22,227.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 236,445 last week, a decrease of 8.5 percent from the prior week's figure of 258,372 and a 548.6 percent increase from the October 2019 weekly average of 36,452. Continued claims under Title 5 totaled 405. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 51,852 while PUA continued claims totaled 419,625. Extended Benefits (EB) continued claims totaled 10,639.
