

Weekly Analysis

October 17, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 17,598 last week, a decrease of 12.2 percent from the prior week's figure of 20,044 and a 177.1 percent increase from the October 2019 weekly average of 6,351. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 56. Pandemic Unemployment Compensation (PUA) initial claims totaled 28,845.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 184,756 last week, a decrease of 10.8 percent from the prior week's figure of 207,212 and a 406.8 percent increase from the October 2019 weekly average of 36,452. Continued claims under Title 5 totaled 404. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 78,608 while PUA continued claims totaled 399,047. Extended Benefits (EB) continued claims totaled 11,637.
