

Weekly Analysis

October 31, 2020

Ohio Law initial claims, representing newly unemployed persons, totaled 21,263 last week, an increase of 21.3 percent from the prior week's figure of 17,531 and a 234.8 percent increase from the October 2019 weekly average of 6,351. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 68. Pandemic Unemployment Compensation (PUA) initial claims totaled 50,075.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 161,221 last week, a decrease of 4.0 percent from the prior week's figure of 167,901 and a 342.3 percent increase from the October 2019 weekly average of 36,452. Continued claims under Title 5 totaled 416. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 90,663 while PUA continued claims totaled 431,405. Extended Benefits (EB) continued claims totaled 13,729.
