

# Weekly Analysis

**December 5, 2020**

Ohio Law initial claims, representing newly unemployed persons, totaled 36,327 last week, an increase of 30.9 percent from the prior week's figure of 27,750 and a 204.7 percent increase from the December 2019 weekly average of 11,924. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 69. Pandemic Unemployment Compensation (PUA) initial claims totaled 43,767.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 152,708 last week, an increase of 6.9 percent from the prior week's figure of 142,816 and a 130.4 percent increase from the December 2019 weekly average of 66,275. Continued claims under Title 5 totaled 521. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 101,160 while PUA continued claims totaled 430,840. Extended Benefits (EB) continued claims totaled 17,650.
