

Weekly Analysis

May 15, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 17,472 last week, a decrease of 12.3 percent from the prior week's figure of 19,926 and a 55.9 percent decrease from the May 2020 weekly average of 39,647. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 31. Pandemic Unemployment Compensation (PUA) initial claims totaled 6,117.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 106,271 last week, a decrease of 3.5 percent from the prior week's figure of 110,126 and a 79.4 percent decrease from the May 2020 weekly average of 516,429. Continued claims under Title 5 totaled 293. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 121,738 while PUA continued claims totaled 299,103. Extended Benefits (EB) continued claims totaled 52.
