

Weekly Analysis

June 26, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 10,473 last week, a decrease of 19.1 percent from the prior week's figure of 12,953 and a 69.8 percent decrease from the June 2020 weekly average of 34,660. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 25. Pandemic Unemployment Compensation (PUA) initial claims totaled 3,978.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 78,750 last week, a decrease of 7.7 percent from the prior week's figure of 85,361 and a 74.8 percent decrease from the June 2020 weekly average of 312,501. Continued claims under Title 5 totaled 239. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 102,357 while PUA continued claims totaled 253,930. Extended Benefits (EB) continued claims totaled 9.
