

# Weekly Analysis

## August 28, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 13,740 last week, an increase of 67.9 percent from the prior week's figure of 8,182 and a 31.5 percent decrease from the August 2020 weekly average of 20,057. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 24. Pandemic Unemployment Compensation (PUA) initial claims totaled 11,442.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 55,022 last week, a decrease of 2.3 percent from the prior week's figure of 56,303 and a 82.6 percent decrease from the August 2020 weekly average of 316,845. Continued claims under Title 5 totaled 195. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 78,944 while PUA continued claims totaled 203,209. Extended Benefits (EB) continued claims totaled 194.
