

# Weekly Analysis

October 9, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 9,851 last week, an increase of 6.8 percent from the prior week's figure of 9,222 and a 48.4 percent decrease from the September 2020 weekly average of 19,090. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 42. Pandemic Unemployment Compensation (PUA) initial claims totaled 302.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 47,458 last week, an increase of 2.1 percent from the prior week's figure of 46,492 and a 71.9 percent decrease from the September 2020 weekly average of 169,012. Continued claims under Title 5 totaled 189. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 3,113 while PUA continued claims totaled 38,241. Extended Benefits (EB) continued claims totaled 162.
