

Weekly Analysis

November 6, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 11,232 last week, an increase of 52.3 percent from the prior week's figure of 7,375 and a 59.3 percent decrease from the November 2020 weekly average of 27,595. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 25. Pandemic Unemployment Compensation (PUA) initial claims totaled 15.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,111 last week, an increase of 9.8 percent from the prior week's figure of 38,360 and a 75.0 percent decrease from the November 2020 weekly average of 168,225. Continued claims under Title 5 totaled 170. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 1,398 while PUA continued claims totaled 21,513. Extended Benefits (EB) continued claims totaled 204.
