

# Weekly Analysis

December 4, 2021

Ohio Law initial claims, representing newly unemployed persons, totaled 9,302 last week, an increase of 23.7 percent from the prior week's figure of 7,519 and a 71.0 percent decrease from the December 2020 weekly average of 32,118. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 32. Pandemic Unemployment Compensation (PUA) initial claims totaled 11.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 39,402 last week, an increase of 26.1 percent from the prior week's figure of 31,235 and a 72.5 percent decrease from the December 2020 weekly average of 143,324. Continued claims under Title 5 totaled 197. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 1,130 while PUA continued claims totaled 14,863. Extended Benefits (EB) continued claims totaled 265.
