

Weekly Analysis

April 30, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,255 last week, a decrease of 24.5 percent from the prior week's figure of 8,283 and a 71.9 percent decrease from the April 2021 weekly average of 22,249. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 9. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 36,121 last week, a decrease of 12.3 percent from the prior week's figure of 41,175 and a 69.3 percent decrease from the April 2021 weekly average of 117,520.

Continued claims under Title 5 totaled 170. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 17 while PUA continued claims totaled 1,480. Extended Benefits (EB) continued claims totaled 12.
