

Weekly Analysis

May 7, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,021 last week, an increase of 12.2 percent from the prior week's figure of 6,255 and a 58.4 percent decrease from the May 2021 weekly average of 16,866. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled 2.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 33,334 last week, a decrease of 7.7 percent from the prior week's figure of 36,121 and a 70.3 percent decrease from the May 2021 weekly average of 112,080. Continued claims under Title 5 totaled 128. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 35 while PUA continued claims totaled 516. Extended Benefits (EB) continued claims totaled 3.
