

# Weekly Analysis

## June 4, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 9,484 last week, an increase of 7.6 percent from the prior week's figure of 8,817 and a 28.2 percent decrease from the June 2021 weekly average of 13,204. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 20. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 28,985 last week, an increase of 1.4 percent from the prior week's figure of 28,587 and a 63.2 percent decrease from the June 2021 weekly average of 78,832. Continued claims under Title 5 totaled 151. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 62 while PUA continued claims totaled 841. Extended Benefits (EB) continued claims totaled 6.
