

# Weekly Analysis

## June 18, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 10,895 last week, a decrease of 3.5 percent from the prior week's figure of 11,295 and a 17.5 percent decrease from the June 2021 weekly average of 13,204. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled 9.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 33,261 last week, an increase of 5.3 percent from the prior week's figure of 31,594 and a 57.8 percent decrease from the June 2021 weekly average of 78,832. Continued claims under Title 5 totaled 142. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 22 while PUA continued claims totaled 1,326. Extended Benefits (EB) continued claims totaled zero.
