

# Weekly Analysis

## July 16, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 11,113 last week, a decrease of 24.5 percent from the prior week's figure of 14,724 and a 2.9 percent increase from the July 2021 weekly average of 10,801. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled 6.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 38,356 last week, an increase of 9.5 percent from the prior week's figure of 35,028 and a 39.2 percent decrease from the July 2021 weekly average of 63,092. Continued claims under Title 5 totaled 164. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 53 while PUA continued claims totaled 1,009. Extended Benefits (EB) continued claims totaled zero.
