

# Weekly Analysis

## October 8, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,218 last week, a decrease of 0.3 percent from the prior week's figure of 7,240 and a 15.8 percent decrease from the October 2021 weekly average of 8,569. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 23. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 27,212 last week, a decrease of 3.8 percent from the prior week's figure of 28,294 and a 40.2 percent decrease from the October 2021 weekly average of 45,491. Continued claims under Title 5 totaled 147. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 72 while PUA continued claims totaled 374. Extended Benefits (EB) continued claims totaled zero.
