

Weekly Analysis

October 15, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 5,954 last week, a decrease of 17.5 percent from the prior week's figure of 7,218 and a 30.5 percent decrease from the October 2021 weekly average of 8,569. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 12. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 27,889 last week, an increase of 2.5 percent from the prior week's figure of 27,212 and a 38.7 percent decrease from the October 2021 weekly average of 45,491. Continued claims under Title 5 totaled 164. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 105 while PUA continued claims totaled 296. Extended Benefits (EB) continued claims totaled zero.
