

Weekly Analysis

October 29, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 6,431 last week, an increase of 0.5 percent from the prior week's figure of 6,396 and a 25.0 percent decrease from the October 2021 weekly average of 8,569. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 27,778 last week, a decrease of 2.0 percent from the prior week's figure of 28,353 and a 38.9 percent decrease from the October 2021 weekly average of 45,491. Continued claims under Title 5 totaled 140. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 76 while PUA continued claims totaled 358. Extended Benefits (EB) continued claims totaled zero.
