

Weekly Analysis

November 12, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 7,664 last week, an increase of 2.5 percent from the prior week's figure of 7,475 and a 8.6 percent decrease from the November 2021 weekly average of 8,385. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 27. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 29,112 last week, an increase of 3.8 percent from the prior week's figure of 28,042 and a 23.4 percent decrease from the November 2021 weekly average of 38,025. Continued claims under Title 5 totaled 151. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 61 while PUA continued claims totaled 212. Extended Benefits (EB) continued claims totaled zero.
