

# Weekly Analysis

## December 10, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 13,077 last week, a decrease of 0.0 percent from the prior week's figure of 13,083 and a 30.8 percent increase from the December 2021 weekly average of 10,001. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 13. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,697 last week, an increase of 8.7 percent from the prior week's figure of 39,269 and a 10.4 percent increase from the December 2021 weekly average of 38,685. Continued claims under Title 5 totaled 183. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 82 while PUA continued claims totaled 369. Extended Benefits (EB) continued claims totaled zero.
