

Weekly Analysis

December 24, 2022

Ohio Law initial claims, representing newly unemployed persons, totaled 13,287 last week, an increase of 18.0 percent from the prior week's figure of 11,262 and a 32.9 percent increase from the December 2021 weekly average of 10,001. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 17. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 48,603 last week, an increase of 4.6 percent from the prior week's figure of 46,456 and a 25.6 percent increase from the December 2021 weekly average of 38,685. Continued claims under Title 5 totaled 168. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 78 while PUA continued claims totaled 246. Extended Benefits (EB) continued claims totaled zero.
