

# Weekly Analysis

## April 1, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 13,260 last week, a decrease of 15.8 percent from the prior week's figure of 15,750 and a 24.8 percent increase from the April 2022 weekly average of 10,623. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled 1.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 55,102 last week, a decrease of 3.1 percent from the prior week's figure of 56,871 and a 32.5 percent increase from the April 2022 weekly average of 41,597. Continued claims under Title 5 totaled 161. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 55 while PUA continued claims totaled 61. Extended Benefits (EB) continued claims totaled zero.
