

Weekly Analysis

April 29, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 5,196 last week, a decrease of 10.5 percent from the prior week's figure of 5,803 and a 51.1 percent decrease from the April 2022 weekly average of 10,623. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 12. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 42,558 last week, a decrease of 5.9 percent from the prior week's figure of 45,218 and a 2.3 percent increase from the April 2022 weekly average of 41,597. Continued claims under Title 5 totaled 160. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 33 while PUA continued claims totaled 100. Extended Benefits (EB) continued claims totaled zero.
