

Weekly Analysis

July 29, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 18,501 last week, a decrease of 13.7 percent from the prior week's figure of 21,443 and a 66.6 percent increase from the July 2022 weekly average of 11,108. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 10. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 43,610 last week, an increase of 5.5 percent from the prior week's figure of 41,331 and a 14.1 percent increase from the July 2022 weekly average of 38,221. Continued claims under Title 5 totaled 103. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 27 while PUA continued claims totaled 22. Extended Benefits (EB) continued claims totaled zero.
