

Weekly Analysis

September 16, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 7,050 last week, a decrease of 1.5 percent from the prior week's figure of 7,159 and a 4.1 percent increase from the September 2022 weekly average of 6,775. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 14. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 34,639 last week, a decrease of 1.4 percent from the prior week's figure of 35,116 and a 34.0 percent increase from the September 2022 weekly average of 25,855. Continued claims under Title 5 totaled 97. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 33 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
