

# Weekly Analysis

September 30, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 6,948 last week, a decrease of 17.9 percent from the prior week's figure of 8,458 and a 2.6 percent increase from the September 2022 weekly average of 6,775. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 35,095 last week, an increase of 4.5 percent from the prior week's figure of 33,583 and a 35.7 percent increase from the September 2022 weekly average of 25,855. Continued claims under Title 5 totaled 105. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 24 while PUA continued claims totaled 7. Extended Benefits (EB) continued claims totaled zero.
