

# Weekly Analysis

October 21, 2023

Ohio Law initial claims, representing newly unemployed persons, totaled 6,158 last week, an increase of 5.9 percent from the prior week's figure of 5,817 and a 9.0 percent decrease from the October 2022 weekly average of 6,765. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 37,448 last week, an increase of 3.6 percent from the prior week's figure of 36,148 and a 19.1 percent increase from the October 2022 weekly average of 31,447. Continued claims under Title 5 totaled 132. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 34 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
