

Weekly Analysis

January 6, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 10,490 last week, a decrease of 12.9 percent from the prior week's figure of 12,041 and a 6.8 percent decrease from the January 2023 weekly average of 11,255. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 19. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 59,790 last week, an increase of 13.4 percent from the prior week's figure of 52,740 and a 11.7 percent decrease from the January 2023 weekly average of 67,730. Continued claims under Title 5 totaled 125. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 4 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
