

# Weekly Analysis

## March 23, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 5,034 last week, an increase of 18.4 percent from the prior week's figure of 4,253 and a 64.9 percent decrease from the March 2023 weekly average of 14,325. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 11. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 50,537 last week, a decrease of 3.4 percent from the prior week's figure of 52,311 and a 1.0 percent decrease from the March 2023 weekly average of 51,047. Continued claims under Title 5 totaled 121. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 35 while PUA continued claims totaled 4. Extended Benefits (EB) continued claims totaled zero.
