

Weekly Analysis

March 30, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 6,210 last week, an increase of 23.4 percent from the prior week's figure of 5,034 and a 56.6 percent decrease from the March 2023 weekly average of 14,325. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 11. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 49,152 last week, a decrease of 2.7 percent from the prior week's figure of 50,537 and a 3.7 percent decrease from the March 2023 weekly average of 51,047. Continued claims under Title 5 totaled 137. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 47 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
