

Weekly Analysis

July 27, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 5,352 last week, a decrease of 30.1 percent from the prior week's figure of 7,662 and a 76.2 percent decrease from the July 2023 weekly average of 22,470. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 13. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 47,914 last week, an increase of 3.2 percent from the prior week's figure of 46,446 and a 1.8 percent decrease from the July 2023 weekly average of 48,784. Continued claims under Title 5 totaled 121. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 33 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
