

# Weekly Analysis

August 17, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 4,945 last week, a decrease of 8.2 percent from the prior week's figure of 5,388 and a 72.1 percent decrease from the August 2023 weekly average of 17,710. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 18. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 43,012 last week, a decrease of 1.8 percent from the prior week's figure of 43,789 and a 18.3 percent increase from the August 2023 weekly average of 36,360. Continued claims under Title 5 totaled 118. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 11 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
