

Weekly Analysis

August 31, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 5,610 last week, an increase of 16.9 percent from the prior week's figure of 4,799 and a 68.3 percent decrease from the August 2023 weekly average of 17,710. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 18. Pandemic Unemployment Compensation (PUA) initial claims totaled zero .

Ohio Law continued claims, representing persons unemployed one week or more, totaled 39,829 last week, a decrease of 4.2 percent from the prior week's figure of 41,557 and a 9.5 percent increase from the August 2023 weekly average of 36,360. Continued claims under Title 5 totaled 106. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 16 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
