

# Weekly Analysis

September 7, 2024

Ohio Law initial claims, representing newly unemployed persons, totaled 4,511 last week, a decrease of 19.6 percent from the prior week's figure of 5,610 and a 40.1 percent decrease from the September 2023 weekly average of 7,536. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 15. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 38,907 last week, a decrease of 2.3 percent from the prior week's figure of 39,829 and a 16.4 percent increase from the September 2023 weekly average of 33,413. Continued claims under Title 5 totaled 106. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 4 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
