

Weekly Analysis

June 7, 2025

Ohio Law initial claims, representing newly unemployed persons, totaled 6,765 last week, a decrease of 0.8 percent from the prior week's figure of 6,818 and a 14.2 percent increase from the June 2024 weekly average of 5,925. Initial claims under Title 5 of the U.S. Code (UCFE & UCX) totaled 16. Pandemic Unemployment Compensation (PUA) initial claims totaled zero.

Ohio Law continued claims, representing persons unemployed one week or more, totaled 47,757 last week, an increase of 4.8 percent from the prior week's figure of 45,560 and a 15.9 percent increase from the June 2024 weekly average of 41,200. Continued claims under Title 5 totaled 180. Pandemic Emergency Unemployment Compensation (PEUC) continued claims totaled 1 while PUA continued claims totaled zero. Extended Benefits (EB) continued claims totaled zero.
